

Concerns have been raised about overgrown footpaths in the Village. Footpath 68 from Oak Avenue to Oak Road is completely impassable resulting in entering a privately owned field to access the path. Footpath 69 from the Shepherd & Dog leading to Crays Hill Road is only partially accessible and very overgrown in places. Clerk to contact Cllr. Buckley regarding footpath maintenance.

A member of the public has raised a concern about overgrown bushes and shrubs on Crays Hill, opposite Crays Hill Road which are causing a significant obstruction on the pavement near a busy stretch of road. The resident has offered to cut back the bushes himself. The Parish Council have prepared letters to properties in Staceys Mount which they believe the bushes may belong to request that they are cut back. Council to await a response before deciding how best to deal with the overgrown bushes.
