

Devolution & Reorganisation

There is a proposal from the Government to give powers to local areas through an elected Mayor. These powers would include transport, education and strategic planning. The budget would be handed down from the Government and the Mayor would decide the spending. This could also affect the Police and Fire Commission. The Mayor would be key to reforming local government.

Twelve Counties are currently in favour of devolution.

The reorganisation of this would mean Borough Councils would be merged. Each new Unitary Authority would cover approximately half a million residents so Boroughs would have to be merged.

Potentially there would be a South Essex Authority. This would take on the services of Borough Councils.

There will be a reorganisation of polling districts.

Essex elections will be suspended in view of the potential forthcoming changes.
