Essex County Council

Budget

In the recent budget Council Tax was increased by 3.75% in total, 2% of which being for adult social care.

An extra £8 million on last year's budget has been allocated to Highways to help with pothole repairs and road maintenance.

Nicole Wood has been appointed as the new Chief Executive of Essex County Council.

Devolution

The consultation for appointment of a Mayor for Essex will open in May 2026.

Government Reorganisation

There are currently 15 local Councils serving 1.9 million people. It is likely that Essex County Council and Basildon Borough Council will be disbanded when reorganisation takes place. There will be

shadow elections in May 2027 and new Councils will be formed in May 2028. The final decision will be made by Jim McMahon, guided by the Treasury but the goal of the reorganisation is to look for long term savings. A compromise letter has been submitted by Essex County Council.

Local Plan/Development

Cllr. Kirby asked Cllr. Ball for an update regarding any infrastructure such as GP Surgery, dentists and schools that may be being considered in line with the large amount of new housing proposed in the local area.
