01/58 APOLOGIES FOR ABSENCE

01/59 MINUTES OF PREVIOUS MEETING

The minutes of the extraordinary Parish Council Meeting on 7th October, 2009 were signed and **agreed**, proposed by Cllr. Lucas and seconded by Cllr. McPherson-Davis.

01/60 DECLARATIONS OF MEMBERS' INTERESTS

01/62 PROGRESS CHECK FROM LAST MEETING

The Clerk updated members on actions from the meeting of 7th October, 2009.

01/63 THREE YEAR PLAN FOR PARISH COUNCIL OBJECTIVES

The Clerk confirmed that suggestions from residents for a three year plan for

precept or other projects to date had not been received. It was **agreed** to carry forward to the November meeting.

01/64 PRECEPT

The Clerk reminded members of the internal auditors recommendation to have a £6,000.00 reserve and urged members that it was also the Clerk's advice for members to consider this. The Parish Council chose not to take this advice.

Cllr. McPherson- Davis proposed and Cllr. Reeve seconded for the decision to be deferred until the November meeting to consider any suggestions from residents for the three year plan as this might affect the precept request – motion was defeated.

Cllr. Peake proposed and Cllr. Lucas seconded that the precept be increased from 2009 – 2010 by 2% for 2010 – 2011.

The majority decision was for the precept to be increased by 2% the exact figures and paperwork would be available at the November meeting for the Chairman's signature.

Cllr. McPherson-Davis requested it be put onto record that he was against the decision having been taken not to wait and decide at the November meeting.

01/65 COMMUNITY INITIATIVES FUND - HIGHWAYS

It was proposed by Cllr. McPherson-Davis and seconded by Cllr. Peake to request CIF Highways funding for an extension on the right hand side footpath to allow pedestrians to walk up Crays Hill – **agreed**.

01/66 ESSEX CLERK'S BURSARY SCHEME

The Parish Council agreed in principle for the Clerk to attend training courses during 2010 with 75% refundable, to be split between Shotgate Parish Council.

01/67 PLANTING

The Clerk confirmed that at the moment in time permission had not been given from B.D.C. to accept the donation for bulb planting on the approach to Hardings Elms Road from the London Road on the left hand side. The Clerk will pursue. The Clerk will write a letter to Hardings Elms Nursery to thank them for the donated plants in Oak Road.

01/68 MINUTES BOOK

The Parish Council agreed to accept the offer of a donation by residents to fund a replacement, proposed by Cllr. Lucas and seconded by Cllr. Peake – **agreed.**

The Parish Council then considered whether to pay for gold embossment on the minutes book. It was proposed by Cllr. Lucas and seconded by Cllr. Peake not to pay for this embossment. There was a vote and the majority decision was that the Parish Council would not pay for the gold embossment.

Cllr. Reeve offered to pay for the embossment. The Clerk thanked Cllr. Reeve for his generous donation and confirmed to the Council that a letter of thanks and acceptance would be distributed and put onto the notice board to thank residents for their kind donation.

01/69 EAST OF ENGLAND REGIONAL ASSEMBLY

The Parish Council considered the consultation response on homes within the area. It was proposed by Cllr. Peake and seconded by Cllr. Reeve that the Clerk

would respond on behalf of the Parish Council that the greenbelt to remain untouched and only controlled infill to be permitted – **agreed.**

01/70 CHRISTMAS TREE AND CHRISTMAS TREE LIGHTS

- (i) The Clerk updated members as to the cost of the purchase of the LED low voltage Christmas lights complying with safety legislation. It was proposed by Cllr. Peake and seconded by Cllr. McPherson-Davis to purchase 200 LED lights at a cost of approximately £24.00 agreed. The Clerk to purchase the lights.
- (ii) The Christmas tree was considered and Councillors Reeve and Peake will ask local businesses if they are prepared to donate a tree. It was **agreed** to defer to the November meeting.
