18/03 APOLOGIES FOR ABSENCE

20/03 MINUTES OF PREVIOUS MEETINGS

Minutes of the Parish Council Meeting held on 14th July, 2010 were approved as an accurate record. Proposed by Cllr. Borer and seconded by Cllr. Reeve – **agreed**.

21/03 POLICE PRESENTATION

P.C. Curtis and P.C.S.O. Caroline Guest.

The following statistics provided are for the whole of the Crouch Ward and not just Ramsden Crays Parish Council.

For the period 20th July – 4th September 2010:

Three common assaults, 6 burglary dwellings, 1 breach of court order, 5 burglary others, 1 criminal damage, 6 criminal damage to dwellings, 1 criminal damage other than dwelling, 9 criminal damages to vehicles, 2 drug cultivations, 3 drug possessions, 1 Public Order Act Section 4, 1 Public Order Act Section 5, 1 robbery, 5 theft of motor vehicles, 5 theft others and 6 theft from motor vehicles.

Forty-three anti-social behaviour incidents from 20th July to 4th September 2010 over a 46 day period for the whole of Crouch Ward. The previous period 8th June to 20th July 2010 over a 42 day period for the whole of the Crouch Ward were a total of 53 incidents. Primary around the Noak Bridge area. "Operation Admonish" has been in operation over school holiday period.

- Speed survey strips out on 14th September informed, not visible today, will pursue. Data will be analysed.
- Accident data 36 months for Crays Hill Hardings Elm Road 6 accidents.
- Parking on pavement causing restricted vision and CCTV in Longwood directed towards private properties. Police not yet had opportunity to look into and will come back to the Parish Council.
- Mobile Police Station is active, recently at Ramsden Bellhouse. Website available to update Council.

Visits have been made to Dale Farm and have been tasked for twice a day.

Cllr. Lucas request for an agenda item for the Parish Council to consider sending a letter to the church authorities requesting a small percentage from the sale of the village hall to allow the Parish Council to apply for match funding to obtain alternative accommodation.

Situation on how many legal sites are permitted on the Dale Farm site.

Cllr. Lucas - resurfacing of the park car park.

25/03 EXTERNAL MEETINGS - REPORTS FROM PARISH COUNCILLORS

4th August Highways Panel – Cllr. D. McPherson-Davis attended this meeting with minimal attendance. Opinion of all at this meeting was that it would be inappropriate for the Panel to be set up for Basildon District to decide where monies should be spent.

Cllr. McPherson-Davis attended a joint hosted Viola Pitsea Marshes Trust and Basildon Council funding seminar where he was informed that funding is available.

26/03 OAK LANE

- (i) The Parish Council reviewed the situation on the eviction process and the way forward with B.D.C. Clerk to write to B.D.C. to request 28 day notice served sooner rather than later and to ask what progress has been made since the last update with all the agencies concerned and why has notice not been served. Additionally to congratulate B.D.C. on the successful eviction from Hovefield.
 - Proposed by Cllr. Reeve and seconded by Cllr. Borer agreed.
- (ii) Considered the response on the issue of legal pitches after the eviction of Dale Farm from B.D.C. Paragraph to add to earlier letter from the Clerk to request what B.D.C. think the position is at the legal site, how many pitches there currently are on legal site and whether any sub-division has taken place? Is it likely that the four or ten year rule will come into effect? How does B.D.C. control the occupation of the legal site?

 Proposed by Cllr. Peake, seconded by Cllr. Reeve agreed. (Letter to A. Ball and cc Ward/District Councillors and John Baron.)

27/03 HARDINGS ELMS ROAD - TRAFFIC RESTRICTION

The reply to the letter of 30th July from Essex County Council was reviewed. The Clerk to send a letter requesting the criteria considering this road incorporates a ditch, no footpath, a windy road and houses on each side.

Clerk requested to write to E.C.C. to move the 30 mph limit on the A129 junction pushing the 30 mph limit westwards towards Billericay beyond the junction of Hardings Elms road in light of continued incidents over the last 3 years and the close proximity of Whites Bridge industrial estate on a blind bend. Proposed by Cllr. Peake - **agreed**.

28/03 AUDIT RETURN

The Clerk to resend report of the full audit to all councilors to be reviewed at next meeting. Proposed by Cllr. Peake - **agreed**.

29/03 STANDING ORDERS

To review at the next meeting the circulated document on the standing orders and agree changes to the current models for Part 2 – **agreed**.

30/03 WAR MEMORIALS

The response from the two specialist companies was considered on.

(i) Restoration and (ii) ulltimate resiting of both memorials.

One company wrote not interested and the other yet to respond.

(iii) The funding information from Wickford Memorial Group was provided to members from Cllr. McPherson-Davis who confirmed they are interested in the First World War Memorial. It was **agreed** to contact them when the Parish Council is aware of the situation regarding the hall.

It was **agreed** to defer consideration for budget preparations towards restoration and resiting to the next meeting.

31/03 CHANGES IN RESPONSIBILITY TO CONCESSIONARY TRAVEL PASSES AND THE PUBLIC CONSULTATION

Proposed by Cllr. McPherson-Davis that current travel regulations to be retained – **agreed**.

32/03 SUMMER NEWSLETTER RESOLUTIONS

- (i) It was resolved that the newsletter is ready for printing and distribution. Proposed by Cllr. Peake and seconded by Cllr. Lucas.
- (ii) It was offered by Cllr. McPherson-Davis and resolved that in future he will put a copy into a folder for future retention in the Wickford Library.

33/03 P11DX

It was **agreed** that Cllr. Peake will review the dispensation form for HM Revenue for the financial year 2010 – 2011and for this matter to be deferred to the next Parish Council meeting.

34/03 CHARTER BETWEEN BASILDON DISTRICT COUNCIL

It was **resolved** that the revised Charter between Basildon Council and Ramsden Crays be accepted.

35/03 ASSOCIATION OF BASILDON LOCAL COUNCILS

It was **resolved** that the amended constitution from BATPC and the name change to Association of Basildon Local Councils and the proposed subscription to £20.00 for the year for the meeting on 15th September, prior to SGM be **agreed**.

36/03 ESSEX COUNTY COUNCIL SOUTH AREA FORUM BUDGET

Consideration was made for funding for this and CIF Funding and Veolia Marshes Trust.

37/03 GRANT FUNDING

Cllr. McPherson-Davis updated the Council that funding is available for the park area. He proposed that an application is submitted by all three current fundings available and on the basis that any additional required funding comes from the other two – agreed.

It was **agreed** that Cllr. McPherson-Davis research and make applications for another goal post in the park and two small 5 a side goal posts and a couple of park benches.

38/03 SCRUTINY REVIEW OF TAXI NUMBERS AND ACCESSIBILITY ISSUES

The two issues under review on the Overview and Scrutiny Review were considered and Council **agreed** not to make any comment.

39/03 CLG CONSULTATION – LOCAL REFERENDUMS TO VETO EXCESSIVE COUNCIL TAX INCREASES

The referendum and its contents were noted by the Parish Council.

40/03 SALT BINS, SALT BAGS AND PARISH COUNCILS

RECOMMENDATION "The Council considered being part of a pilot scheme with 1 tonne salt bags as an alternative to salt bins". It was **resolved** that the Clerk to respond with a "no thank you"..

41/03 BUDGET - PRELIMINARY - PRECEPT

It was **agreed** to review the preliminary budget and precept at the next Parish Council meeting.

42/03 PENSION - CLERK

RECOMMENDATION "To consider the options available for the Clerk to join the local government pension scheme". The Clerk will forward information to members – agreed.

43/03 NATURE RESERVE

The response of the letter of 1st July from B.D.C. was considered for the future intention of the maintenance and possible development of this area. The Clerk was instructed to write to ask "that considering the amount spent at Wat Tyler Park and elsewhere does B.D.C. not think Ramsden Crays can receive a minimal maintenance. Proposed by Cllr. Peake and seconded by Cllr. Borer - **agreed**.

44/03 CRAYS HILL PRIMARY SCHOOL

The latest letter from the school for provisions of dates for meetings during 2011, with a request for a copy of the insurance provision for public liability prior to first meeting was considered. The Clerk to write and give dates from 1st January 2011 and to provide a copy of the insurance provision - **agreed**.

RECOMMENDATION "To consider listing of the facia of Crays Hill School". Cllr. Borer proposes that the Clerk looks into information on listing the frontage facia of Crays Hill school as a listed building – **agreed**.

45/03 FOOTPATH 69

Cllr. Borer proposed that the PC writes to the relevant department for a gate as has been used frequently by horses coming out of the area – **agreed**.

46/03 PLAYING FIELDS

Cllr. Borer proposed that the Council consider applying for the playing fields to

become village greens. The Clerk to receive information from Cllr. Borer and make further enquiries - agreed.

Cllr. Reeve offered to put up and decorate a Christmas tree. He proposed to make an enquiry of a local resident for a donation of the tree as in previous year's - agreed.
