## 06/11 CHURCH HALL

war memorial was considered.

Cllr. Peake informed members that he had spoken to a museum in Chelmsford who had agreed to store both the stone and wooden memorials in a regimental museum whilst the Parish Council confirms relocation. Further update at the next meeting.

Cllr. McPherson-Davis advised that a resident has offered to put the stone memorial in the field at the corner of Approach Road. It was **agreed** to review at the next meeting. The Clerk will write to thank the resident for the offer and to confirm exact location.

## 07/11 LEGAL SITES ON DALE FARM SITE

Response noted on the situation on how many legal sites are permitted on the Dale Farm site. This will be referred to Basildon Borough Council at its meeting on 20<sup>th</sup> January, 2011.

# **08/11 OAK ROAD**

- (i) The current situation at Oak Road was reviewed, including the road deterioration.
  - Litter on the ditches and the road has deteriorated and is not being cleared once a week as previously. Basildon Borough Council Street Care to receive a request for improvements and signs to put installed to dispose of litter properly.
- (ii) The 30 mph signs in Oak Road have not reappeared. The exact locations for replacement signs to be provided to Street Care to assist in the prevention of vehicles driving into the ditches.

Cllr. Peake confirmed he had liaised with Basildon that this was an ongoing problem To date Basildon Borough Council confirmed that there is no funding. A site meeting is scheduled in the next couple of weeks and at this meeting they will be asked how they intend to maintain it. Update should be available at the next Parish Council meeting – agreed.
