53/13 MINUTES OF PREVIOUS MEETINGS:

56/13 PLANNING APPLICATIONS:

Application No: 13/00186/FULL. Retrospective consent sought for a detached single family dwelling house.

Location: Ormonde, Gardiners Lane North, Crays Hill, Billericay, Essex. Objection as initially aware one dwelling was granted planning permission on this site.

Application No: 13/00192/FULL. Demolition of existing bungalow and construction of a detached house.

Location: Hazledene, Crays Hill Road, Billericay, Essex. No objection.

57/13 RE-SITING OF STONE MEMORIAL – WOODEN MEMORIAL:

- (i) To date ECC Highways has not confirmed if it is able to provide additional space to locate memorial planters at the war memorial on the grass verge. Clerk to contact and explain that the Parish Council is in a position to commence works.
- (ii) Installation date for the stone memorial to be confirmed.
- (iii)It was noted that the Clerk wrote and thanked the Rotary Club for its donation of £850.00.
- (iv) Fencing around war memorial to be considered.
- (v) Insurance is to be arranged prior to installation.

58/13 CHURCH HALL:

- (i) To date no additional response received from the Diocese.
- (ii) One response received from Charity Commissioners to the letter sent to them in relation to any proceeds of sale to the residents of the Parish which requested documentation to be sent. The Clerk duly responded and further reply awaited.

59/13 FOOTPATH 69 - KISSING GATE:

ECC Highways have liaised with the residents for the kissing gate at footpath 69 to be correctly installed and completed. Confirmation was not available that this had been finalized. It was **agreed** that ClIr. Borer would visit the site and if the work is still outstanding, the Parish Clerk will contact ECC to request enforcement action.

60/13 VILLAGE SIGN:

A resident has looked around the areas for a village sign. Cllr. Peake will make further enquiries.

61/13 PLAY EQUIPMENT:

The Parish Council noted that the request for funding to Veolia of £7,000.00 has been applied towards the aerial runway with quotations and decision on preferred supplier and costings. The panel is scheduled to meet in May.

62/13 HIGHWAYS:

- (i) Cllr. Don Morris provided an update on requests to date from Highways. Confirmation received that ditches at Gardiners Lane North are scheduled to be cleared.
- (ii) Cllr. McPherson-Davis confirmed that although the reduction in speeding at Hardings Elms Road had been agreed by Highways, implementation of any changes can be expected to be a year.

Clerk to write for clarity of a submission date to panel and confirmation of the issues that were submitted to the Highways panel for Ramsden Crays.

- (iii) Cllr. Peake to contact John Baron MP in relation to incomplete resurfacing of Oak Road by ECC Highways, reduced speeding in Hardings Elms Road and drains in Harding Elms Road.
- (iv) The responses received in relation to Freedom of Information on last two Basildon Local Highways Panel meetings were noted. Clerk write to Essex County Council Highways confirming that it has examined the minutes of the meeting and found them not transparent in relation to location, figures etc.
