# 35/14 CHURCH HALL:

Response awaited from the latest request from the diocese solicitors on St. Marys Church Hall, Crays Hill, Ramsden Crays.

## **36/14 HIGHWAYS:**

On finalizing of works currently being carried out within Ramsden Crays, to then review with the exception of the speeding signs and drainage (David's).

- (i) Progress on the list provided for ECC Highways Panel.
- (ii) Incomplete resurfacing of Oak Road.
- (iii) Clearance of drains in Hardings Elms Road.
- (iv) Update from Essex County Councillors for support in the increase in potholes throughout the Parish, considering the major risk to motorists. Large pothole opposite Oak Avenue.
- (v) Overgrown area with barbed wire at Oak Avenue from Oak Road end to Hemmings end.
- (vi) Conditions of pathways in the village, especially from the Shepherd and Dog Public House to Gardiners Lane.
- (vii) To note that two signs have now been installed to indicate Crays Hill Recreation Park. Cllr. John Dornan and Cllr. Terri Sargent have been thanked for their support in obtaining these.
- (viii) Hedges to be cut back within the Parish, including Oak Road.
- (ix) Foliage/trees to be cut back at the entrance to Crays Hill Road and trees blocking lighting.
- (x) Trees at the junction of the main road. Foliage on the main road and by the speed signs to be cut back.
- (xi) Rubbish by the recycling area in the car park by Ramsden Crays car park to be cut back resolved.
- (xii) Pathway to the park foliage to be cut back.
- (xiii) Speeding reduction signs to note that ECC has agreed to the reduction speed signs on the A129 and also in Hardings Elms Road.
- (xiv) Update on the request for the trees in Oak Road at the Gardiners Lane North area to be trimmed to reduce risk of these and the overhead power cables touching and reducing power service. Not yet resolved. Clerk will continue to pursue.
