**Application No: 14/00569/FULL**. Side extension above existing garage with new first floor and accommodation in roof space.

**Application No: 14/00643/PDPA.** Prior notification for the construction of a single storey rear extension extending 4m beyond the rear wall of the original elevation, with a maximum height of 3.8m and an eaves height of 3.0m.

## 64/14 COMMUNITY PROJECTS:

- (i) Update received on the village sign that the area has been viewed, the plinth will be repaired and Basildon Borough Council will report back in due course on time scale/plans timeframe of three months.
- (ii) It was confirmed that the final approval has been received from Veolia North Thames Trust for its offer of £7,400.00 funding towards the stone wall, following the signed acceptance from the Parish Council.
- (iii) The figure for costings and work for the stone wall prior to contacting the supplier to request work to be carried out was **agreed** at £8,600.00 plus VAT at £1,720.00 = £10,320.00 received of the lowest quote. Proposed by Cllr. Peake and seconded by Cllr. Borer.

- (i) It was noted that Basildon Borough Council had not had the opportunity to clean the two plastic gateways. The Clerk will pursue.

- (iv) No further update on clearance at ground level of the footpaths within the Parish, especially no. 69 following request from the Parish Council. Request a programme of maintenance from footpaths.
