Application No: L2015/216/SLH. Wickford Main Car Park. Hatching down and restrict all vehicles from stopping on the parts of the land shown hatched except for Heavy Commercial Vehicles for deliveries to the adjacent shops only.

In Lake Meadows Car Park, Billericay the bays marked "Coaches" to be designated only for that class of vehicle. Currently this is not enforceable.

- (ii) No progress via Essex County Council at Hardings Elms Road, regarding the flattening of one bollard. Cllr. Buckley will enquire further.
- (iii) No update received on the request to repair on the road/pavement potholes for wheelchair access along the London Road near the Shepherd and Dog. Cllr. Buckley offered to make further enquires.
