# 92/16 ELECTION OF CHAIRMAN:

- (i) It was proposed by Cllr. Aungier to elect Cllr. Peake as Chairman, seconded by Cllr. Flint **agreed**.
- (ii) The Chairman signed the declaration of acceptance of office.

# 93/16 ELECTION OF THE VICE-CHAIRMAN:

It was proposed by Cllr. Peake and seconded by Cllr. Flint to elect Cllr. Aungier as the Vice-Chairman – **agreed**.

# 94/16 DECLARATIONS OF ACCEPTANCE OF OFFICE:

- (i) Councillors received and signed acceptance of office as councillors, this was signed and received by the Clerk at the meeting.
- (ii) Members noted their duty to register any interests under paragraphs 13 and 14 of the Code of Conduct, to provide written notification to the Monitoring Officer and throughout the year and within 28 days of being aware of any changes.

(ii) to (iv) above were reviewed and item (vi) and it was proposed by Cllr. Peake and seconded by Cllr. Flint not to have any changes to these policies – **agreed**.

## 02/16 DECLARATIONS OF MEMBERS' INTERESTS:

No "prejudicial" or "non prejudicial" interests relating to items on the agenda were received.

### 03/16 PUBLIC SESSION:

- (b) Essex County Council update by Cllr. M. Buckley.

At the AGM of ECC primarily the same administration. 90,000 blocked drains are timetabled to be cleared every year but there are considerably excess of this at the current time. He has asked for an improvement.

Policing Crime Commissioner elected recently and there is a suggestion for Specials appointed in Parish areas, they are warranted officers and a project could be combined between Ramsden Crays and Ramsden Bellhouse. 16 hours a month is the minimum. Criteria to be provided via an information pack to the Parish Council.

### 06/16 COUNCILLOR VACANCY:

As per the election and a vacancy in the parish council it was **agreed** that a notice be displayed on the notice board and if viable through a newsletter the vacancy for cooption to the Parish Council for the June meeting.

### 07/16 STAFFING:

The Appraisal Form was received by all the Councillors. The Clerk and at least the Chairman to review prior to the June meeting.

### 08/16 COMMUNITY PROJECTS:

(i) Members reviewed an overall project for application for funding for ECC CIF for July for an additional notice board, benches in the park, an additional waste bin near the Shepherd and Dog and cleaning/improvement of the bus shelters within the Parish.

Cllr. Peake has made enquiries regarding the bus shelters information and will inspect and report with improvements and costings.

Cllr. Peake has received costings on benches in the park via Basildon for secure benches. All to be reviewed at the June meeting for the funding.

(ii) It was **agreed** that the date of the War Memorial Service in November to be

included in the next newsletter and nearer the date to issue flyers and invitations and to reaffirm with Great Burstead Church regarding the Order of Service.

- (iii) It was **agreed** to review an Action Plan for future projects for the Foundation Award Scheme and audit purposes.
- (iv) Consideration was discussed on a proposal received from Basildon for new woodland planting at Crays Hill Recreation Ground at the corner of Hardings Elms Road. Cllr. Peake will meet with Basildon officers to discuss this further.

## 09/16 HIGHWAYS – BASILDON BOROUGH COUNCIL:

No progress received via Essex County Council at Hardings Elms Road, regarding the flattening of one bollard, Cllr. Buckley has pursued this and to date no positive response.

## 10/16 CRAYS HILL PRIMARY SCHOOL – GOVERNING BODY:

The additional response to the request for full minutes from November 2014 to date was reviewed. It was proposed by Cllr. Peake and seconded by Cllr. Flint to take no further action - **agreed**.

## 11/16 PENSION CONTRIBUTION – PARISH COUNCIL:

In line with the government policy, Cllr. Aungier is following enquiries regarding consideration of the ECC LGPS Pension or another.

# 12/16 DALE FARM – OAK LANE/OAK AVENUE:

No updates received on this situation in Oak Lane. The Parish Council has asked if Basildon can confirm when it will take the opportunity to reinstate the ditch and the fencing as the vehicles from this area have now been removed.

- (ii) The Parish Council was informed by residents that some of the land in Oak Lane has been sold to a developer. The Clerk to write to Basildon to confirm if there is a charge on the sites to reclaim monies from the land?
