50/19 Appointment of Chairman:

- (i) Proposed by Cllr. Kirby and seconded by Cllr. Jenkins to appoint Cllr. D. McPherson-Davis as the Chairman **agreed**.
- (ii) The Chairman signed acceptance of office.

51/19 Appointment of Vice-Chairman:

Proposed by Cllr. Jenkins and seconded by Cllr. Finn to appoint Cllr. M. Kirby as Vice-Chairman - agreed.

52/19 Apologies for Absence:

No apologies for absence.

53/19 Minutes of Previous Meetings:

The minutes of the Parish Council Meeting held on Monday 18th March, 2019 were proposed by Cllr. Jenkins and seconded by Cllr. McPherson-Davis as an accurate record - **agreed**.

57/19 Public Forum:

No issues raised by the public on items on the agenda.

Borough and County Councillors:

Cllr. Ball - ECC - Consultation on the bus services have been received over 4,000 responses of which 50% in favour and the same number against. Library consultation over 21,000 responses – initial review not as positive as the bus service.

Local Highways Panel – the Representative from the Parish Councils now has a vote. Chairman confirmed ECC has not received any correspondence. On review from Cllr. Ball it was noted the e-mail sent was mistyped. Cllr. Ball will contact to resolve this.

Task and Finish Group finalised with over 20 recommendations. Online access for residents to review of Ringway Jacobs contract and expectations over the next 5 years.

Footpath 69 on the Rangers List should be completed this month. All issues in the Parish to be communicated via ECC Councillors. A request was made for brambles along Crays Hill road near the bus shelter opposite Crays Hill Primary School, to be removed. Nothing as yet to respond with regard to ECC website regulations.

Corner Road and Approach Road updates on the planning issues in this area received initially via Basildon Borough Council. The enforcement officers have attended and confirmed the land that has been covered in hard core has been issued instructions to remove as on greenbelt land. This has not been removed, but covered in topsoil that has been reported to enforcement.
